**Heat Pump Rebate**

Members who **replace existing** HVAC equipment are eligible to receive a **\$100** rebate for a 15 SEER (with an HSPF of 8.2) High Efficiency Heat Pump and a **\$200** rebate for a 16 SEER (with an HSPF of 9.0) High Efficiency Heat Pump (or higher). The member must provide a copy of the receipt and the Air-Conditioning Heating and Refrigeration Institute (“AHRI”) certificate from the installing contractor for verification purposes. This incentive rebate is not applicable for homes that use natural gas for heating or installation of a new unit.

**HVAC Tune-Up**

Residential members who perform an HVAC tune-up by a qualified service professional can receive a \$100 rebate on an annual HVAC tune up (**not per unit, the HVAC tune up is for all units**) which includes: checking and correcting the unit’s refrigerant pressure and tubing, checking and adjusting belt tension, cleaning and lubricating the indoor blower unit, replacing filters, cleaning inside the “A” coil, and checking the thermostat, wiring, and other electric components.

An itemized copy of the receipt from a qualified contractor stating that the work above has been completed must be provided for verification purposes.

### **Energy Star® Home Rebate**

Members who build **Energy Star®** rated homes (that closed after June 1, 2009) are eligible to receive a \$500 rebate. A copy of the **Energy Star®** certificate is required to be eligible for this program.

### **Ceiling Insulation**

The recommended R-values for existing homes in the BEC Service Area are R38 for the ceiling. Members who upgrade from an **R8 or less** to an **R38 or greater** insulation in their home can receive a **\$275.00 rebate**. A copy of the installation receipt that states the current R8 factor and the new R factor is required. This section must be signed by your installer.

### **High Efficiency Water Heater**

Replacement of your existing water heater to a high efficiency model of a least **.94** qualifies for a **\$25 rebate**. A copy of the receipt is required for this rebate.

### **Additional Miscellaneous Rebates**

The following rebates to home water heating system upgrades apply: Low Flow Showerhead \$10.00 rebate; Low Flow Faucets Aerator \$5.00 rebate Water Heater Blanket \$15.00 rebate (*Be sure to check and see if this is approved by the manufacturer*) Pipe Wrap \$10.00 rebate. A copy of the receipt is required for this rebate.

**Energy Star Room Air Conditioners**

Members who install an **ENERGY STAR®** unit qualify for a **\$30 rebate**. A copy of the receipt and documentation stating that the unit purchased is an **ENERGY STAR®** certified product.

**Energy Star Dishwasher (Electric Water heating only)**
